Dear Mr Thornton,

1968 September as 10 year old child in I had the misfortune of being sent to Green Field House Ray Park Road Maidenhead a children's home that was the centre of a paedophile ring. In December 1970 Maidenhead Council became aware of this paedophile activity and brushed it under the carpet as best they could.

Below is a factual overview of what has been happening more recently in regard to this children's home;

2006 29th November RBWM settled out of court with 9 Green Field House abuse victims. **(SEE PAGE 83 RMPM)** 5 of the 9 victims claimed to have been raped or abused by Denham Gilbert-Smith. Immediately after agreeing these 9 compensation claims, **RBWM** sued Gilbert-Smith to recover their loss.

2007 March Gilbert-Smith with his Uxbridge barrister travelled to Nottingham to meet with barristers who were acting for **RBWM's** solicitors Browne Jacobson. Gilbert-Smith wrote out a cheque the same day for around £1.5M. **(SEE PAGE 88 RMPM)** It was during this meeting that **RBWM** conspired with Gilbert-Smith to make the paedophile deal secret, regardless of any hindrance to a potential future criminal investigation. **RBWM** further agreed that Gilbert-Smith would be *excluded from future litigation if **RBWM** paid out compensation to any more victims who were raped by Gilbert-Smith. **(SEE PAGE 89 RMPM F.O.I.)**
*It doesn't state that exclusion clause in the F.O.I. but if you ask the exclusion question in a new F.O.I. that is the answer you will get!

I don't have an issue with **RBWM** suing Gilbert-Smith to recover their loss. However, I do have an issue **RBWM** entering into secret paedophile deals which VERY CLEARLY pervert the course of justice and would 100% hinder any future criminal prosecution! Which is exactly what happened **(SEE PAGE 118 RMPM VIDEO LINK)**

2008 23rd September RBWM settled out of court with five more victims who were ALL raped or abused by Gilbert-Smith. By 2010 **RBWM** had settled a total of 21 claims of which at least 12 were to victims that had been raped/abused by Gilbert-Smith.

I was one of the Sept 2008 five claimants **(SEE ITEM 1 THE BASIS OF MY CLAIM)** and received a £50,000 payment from **RBWM**. **(SEE ITEM 2) RBWM** settled my compensation claim for the abuse that I suffered at the hands of Gilbert-Smith. Had I been aware that **RBWM** had secretly agreed to protect Gilbert-Smith whilst totally once again neglecting my interests, I would NEVER of settled out of court with **RBWM!**

2009 24th July Gilbert-Smith was arrested. **(SEE CHARGE SHEET PAGE 92)**

2010 17th May Gilbert-Smith stood trial for 17 charges of raping and abusing 8 kids. The secret £1.5M payment to **RBWM** was not allowed to be mentioned in the trial. **(SEE PAGE 93 RMPM)**

2011 5TH July I was sent to prison for 12 months for contempt of court. **(SEE PAGE 132 RMPM)** Since being released from prison I have sent Maidenhead MP The RT Hon Theresa May numerous letters outlining my concerns regarding **RBWM** and this £1.5M corrupt paedophile payment which quite clearly PERVERTED THE COURSE OF JUSTICE!

The RT Hon Ms May has refused to correspond and respond to my concerns about RBWM. As my MP could you please find out;

- 1. Did RBWM** have a duty of care to inform me of this secret agreement when I accepted their compensation offer in 2008?
- 2. Is it amoral & appropriate for RBWM** to make secret deals with a person they believe to have raped a dozen or so kids in their care?
- 3. Will my complaint (SEE ITEM 3) of 3 murders, police corruption, blackmail, RWBM & Gilbert-Smith** perverting the course of justice and jury nobbling be properly investigated by Maidenhead police?
